Annual President's and General Manager's Report

lease make plans to attend the Annual Meeting of the Members on September 5th. Each membership registering at the annual meeting will receive a \$10 energy credit on their electric bill plus a chance to win *FREE ELECTRICITY for a whole year as the grand prize or *FREE ELECTRICITY for six months as the consolation prize. If you've never been to an Annual Meeting or haven't attended recently, please join us and your fellow members this year and participate in one of the most valuable benefits of being a member - the election of your local board of directors. The ballot for this year is being mailed separately so look for it in your mailbox and follow the instructions provided. Your mail-in ballot must reach our office BEFORE the meeting to be counted. You may also cast your ballot in person at the Annual Meeting. 2018 was another solid year for your electric cooperative. We had record sales of electricity (111,133,513 kilo-watt hours) which were 8.34% higher than 2017 and beat budget by 6.22%. After all expenses, we recorded total margins of \$821,473 which was 34.64% less than 2017 and 20.13% less than budget. This decrease in margins was due to additional depreciation charges recorded for the planned retirement of our existing automated metering infrastructure. During the year deferred patronage dividends of \$315,041 were retired (paid out) to current and former members. Since inception, a total of \$8,540,687 has been returned to the members. We were able to meet the financial targets set by our lenders and an independent audit of the books resulted in a clean audit opinion.

Reliability of service and ensuring that our electric grid is resilient is a top priority here at your cooperative. In 2018, we spent \$1.84 million on operations and maintenance of the electric distribution system and also added \$3.03 million of new utility plant. Continual improvement and increased investment in the electric system infrastructure is necessary. We operate and maintain 2,533 miles of electric line and this is a commitment we take very seriously. Our Average Service Availability Index (ASAI) in 2018 was 99.9723%, including major storm events. In other words, the average member was without power 146 minutes during the year.

Day to day, it can be easy to forget just how different we really are from other energy companies. That can be true in any industry—over time, the exceptional starts to seem ordinary. But while talking with the Member Advisory Committee earlier this year, we were struck once

again by how remarkable our electric cooperative really is. The Member Advisory Committee has given us great feedback that will help us in our goal of engaging our membership and remaining relevant to them. Last October we conducted a member survey to get feedback on how we are serving your needs. Of the responses received, 92.21% indicated that they were satisfied or very satisfied with Southwest Iowa REC. A good response indeed but we also see it as a challenge to improve that result.

Before this starts to sound immodest, let's make something clear: What makes us remarkable is you. After all, as an electric cooperative, we are led by consumer-members like you who understand and listen to the community. We don't answer to outside investors who are only interested in using us as a way to make a buck. And this key difference has been part of the plan from the beginning. You see, we were built by the communities we serve from day one, which means that we have been shaped to respond to the specific needs of you and your neighbors. As an electric cooperative, we were created from the ground up by the people who live here and have a long-term interest in seeing their communities thrive. We are proud to invest in our communities through programs like Operation Round Up® which makes charitable awards to deserving groups and individuals. Since inception in 2009, \$217,459 has been awarded. This is made possible by the generous and voluntary contributions of our members. We also invest in our youth by annually sponsoring a student to participate in the national Youth Tour event in Washington D.C. This event is a great opportunity for our future leaders to learn more about cooperatives and our political system. Anika Wenstrand was our representative this year and she will share highlights of her experience at the annual meeting. Another great program we offer is scholarships which are awarded on a competitive basis to graduating seniors choosing

to further their post-high school education. If you live on our lines today, you're playing an important role right now in shaping our future as an energy company. Your choices help us in our mission to efficiently deliver affordable, reliable, and safe energy. Thanks to you, we've secured 24/7 energy sources and a balanced energy mix to make that possible. We're also investing in more efficient technology, like the new automated metering system which was recently installed, and cleaner sources of energy to ensure that tomorrow is even brighter for our consumer-members. One great example of this is the Southwest Solar Farm located just west of Corning that came online in February 2018. This 2-megawatt solar farm consists of 7,128 panels that produces enough electricity on average to power 300 homes each year. This clean source of renewable electric generation is owned by all of you and it directly serves local member load requirements. All these decisions and advances are thanks to people like you, because we belong to the communities we serve. So sure, you may be used to getting your energy from us, but we love the energy we get from you.

It's a pleasure to serve you and we hope to see you at the annual meeting on September 5th where we will share additional information on the positive things happening at your cooperative. Thank you!

2018 Annual Meeting of Members

The Annual Meeting of the Members of Southwest Iowa Rural Electric Cooperative was held at the Lenox Community Center in Lenox, Iowa at 7:00 p.m., on the 13th day of September, 2018. The meeting was called to order by Marilyn Werner, President of the Cooperative, who presided as Chairman, and Richard Ballantyne, Secretary of the Cooperative, acted as Secretary of the meeting and kept the minutes thereof. Chair Werner introduced the guests in attendance at the meeting. Special recognition was awarded to Directors and employees for their years of service. Also present were Attorneys John Ward and Amanda James of Sullivan & Ward, P.C.

An invocation was offered by Director Richard Ballantyne and followed by the recitation of the Pledge of Allegiance.

The Chair stated that the members who had registered at the door had been checked, and that a quorum was present for the transaction of business. She stated that it would be in order for the registration to be accepted in lieu of roll call, whereupon a motion was duly made, seconded and carried, to accept the members' registration at the door in lieu of roll call. The Report of the Nominating Committee was ordered to be identified by the Secretary and annexed to the minutes of the meeting. The Chairman then appointed Sheri Berggren, Fred Berggren, Douglas Wallace, Carolyn Burroughs, Mary K. Overholtzer, John A. Overholtzer, Jack A. Stephens and Charles Abarr as Inspectors of Balloting. The ballots were delivered to the Inspectors, who proceeded to count the same.

Upon motion duly made, seconded and carried, the reading of the minutes of the Annual Meeting of the Members of Southwest Iowa Rural Electric Cooperative held on September 7, 2017 was waived. The minutes were thereupon declared approved and were ordered to be filed in the records of the Cooperative.

The annual report of the President was presented. Copies of the President's report had been distributed to the members and appeared in the Annual Meeting program. President Werner introduced the directors and their spouses. Following discussion, the annual report of the President was directed to be filed in the records of the Cooperative.

The annual report of the Treasurer was presented. The members had received copies of the Treasurer's report, in the form of the balance sheet and statement of revenue and expense for the year ending 2017, both of which were published in the Annual Meeting program distributed to the members. Following discussion, the annual report of the Treasurer was approved and directed to be filed in the records of the Cooperative.

Chair Werner introduced Youth Tour winner Mallorie Wookey who presented a report on the Youth Tour to Washington, D.C. and thanked the Cooperative for sending her.

The annual report of Manager Phil Kinser was presented. After presentation, the report was directed to be filed in the records of the Cooperative. Mr. Kinser introduced the employees of the Cooperative and commented on the length of service of the employees. A legislative update was presented by IAEC representatives Kevin Condon and Haley Smith. A presentation of the Southwest Solar Farm update was provided by Central Iowa Power Cooperative representative Terry Fett.








Nominee Bio's




